- 1. Set up of exhibits from 10am to 4pm on Wednesday 11th December
- 2. The festival will be open to the public from 10.30am to 4.30pm on 12th, 13th and 14th December
- 3. Trees to be removed after morning service on 15th December between 11.30am and 3pm by the exhibitor or purchaser (if advertised for sale and sold)
- 4. Trees to be a maximum height of 6 ft (1.83 metres) and width of 3 ft (90 cms)
- 5. Trees can be fresh trees, artificial or any alternative material
- 6. Lighting should be battery-operated only
- 7. Exhibitors are wholly responsible for their own tree, stand, pot, lights and their removal
- 8. Small trees will be exhibited on small tables, to be provided by the exhibitor
- 9. Exhibitors should email the following to benefice@newforestparishes.com by 14th November
  - \* proposed tree design
  - \* approximate size of tree
  - \* whether the tree is to be sold for the nominated charities or collected by the exhibitor
- 10. The prepared plan showing the placing of exhibits must be strictly observed as this will be reflected in the programme
- 11. The exhibitor is to provide details of their organisation and their exhibit alongside the tree and sale price, if appropriate. Proceeds of the sale will be paid to the exhibitor within 10 days of the event, unless donated to festival fund raising
